Brakes-condition of lines, pads (minimum of 3/8") Rotors-no heat cracking or wear beyond factory tolerance. Brake Fluid-Reservoir level is OK. <i>Brakes bled within the last 90 days.</i> Firm pedal	/		/
Battery-hold downs secure-terminals covered			
Steering-front suspension-NO excessive play			
Wheel Bearings-properly adjusted and greased	/		/
Anti-Sway Bars-check installation & mounts. A COMPLETE "nuts & bolts" check should be done. Every bolt on any suspension piece or any other part should be checked for tightness at every 15k service or at least once a year.	/		/
Shock Absorbers-No leaks. Bushings are not cracked or damaged.	/		/
Axle Boots-CV Joints-no rips or tears, in good condition			
Carbs-Injection-check linkage & return springs-no leaks			
Fuel Lines-secure attachment, safe routing, no leaks, chafing or damage			
Oil-Coolant Lines-secure attachment, safe routing, no leaks, chafing or damage	/		/
Wiring & Cables-secure attachment, safe routing, no chafing or damage	/		/
Fan Belt-Check for cracks and proper tension.			
Exhaust System-no holes, no leaks, properly suspended & clamped			
Seats-Secure mounting. Pedal pads-good non-slip surface

Door-Hood & Trunk Lids-Catch operation is ok.			
Mirrors-Rear view required.
